1 Section 1. Section 331.606A, Code 2005, is amended to read
2 as follows:

3 331.606A DOCUMENT CONTENT -- USE OF SOCIAL SECURITY NUMBER
4 PROHIBITED -- EXCEPTIONS.

5 The preparer of a document shall not include an
6 individual's federal social security number in a document that
7 is prepared for recording in the office of county recorder and
8 the recorder may delete a federal social security number that
9 is incorrectly included in a document that is prepared for
10 recording. This section does not apply to a preparer of a
11 state or federal tax lien or a military separation or
12 discharge record that is prepared for recording in the office
13 of county recorder. If a military separation or discharge
14 record is recorded in the office of the county recorder, the
15 military separation or discharge record shall not be
16 accessible through the internet.

17 EXPLANATION

18 Current law provides that documents filed with the county
