A BILL FOR

1 An Act relating to identification of publicly owned motor
2 vehicles used by persons who provide off-site or in-home
3 medical or mental health services.

4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. Section 321.19, subsection 1, unnumbered
2 paragraph 2, Code Supplement 2005, is amended to read as
3 follows:

4 The department shall furnish, on application, free of
5 charge, distinguishing plates for vehicles thus exempted,
6 which plates except plates on state patrol vehicles shall bear
7 the word "official" and the department shall keep a separate
8 record. Registration plates issued for state patrol vehicles,
9 except unmarked patrol vehicles, shall bear two red stars on a
10 yellow background, one before and one following the
11 registration number on the plate, which registration number
12 shall be the officer's badge number. Registration plates
13 issued for county sheriff's patrol vehicles shall display one
14 seven-pointed gold star followed by the letter "S" and the
15 call number of the vehicle. However, the director of the
16 department of administrative services or the director of
17 transportation may order the issuance of regular registration
18 plates for any exempted vehicle used by peace officers in the
19 enforcement of the law, persons enforcing chapter 124 and
20 other laws relating to controlled substances, persons in the
21 department of justice, the alcoholic beverages division of the
22 department of commerce, disease investigators of the Iowa
23 department of public health, the department of inspections and
24 appeals, and the department of revenue, who are regularly
25 assigned to conduct investigations which cannot reasonably be
26 conducted with a vehicle displaying "official" state
27 registration plates, persons in the Iowa lottery authority
28 whose regularly assigned duties relating to security or the
29 carrying of lottery tickets cannot reasonably be conducted
30 with a vehicle displaying "official" registration plates, and
31 persons in the department of economic development who are
32 regularly assigned duties relating to existing industry
33 expansion or business attraction, and mental health
34 professionals or health care professionals who provide off-
35 site or in-home medical or mental health services to clients

1 of publicly funded programs. For purposes of sale of exempted
2 vehicles, the exempted governmental body, upon the sale of the
3 exempted vehicle, may issue for in-transit purposes a
4 pasteboard card bearing the words "Vehicle in Transit", the
5 name of the official body from which the vehicle was
6 purchased, together with the date of the purchase plainly
7 marked in at least one-inch letters, and other information
8 required by the department. The in-transit card is valid for
9 use only within forty-eight hours after the purchase date as
10 indicated on the bill of sale which shall be carried by the
11 driver.

12 EXPLANATION

13 This bill allows the issuance of regular registration
14 plates, rather than plates bearing the word "official", for
15 certain publicly owned motor vehicles used by health care and
16 mental health professionals who provide off-site or in-home
17 medical or mental health services. In addition, such vehicles
18 would no longer be required to be labeled as publicly owned
19 vehicles.

20 Current law exempts vehicles owned or leased by a
21 governmental agency from vehicle registration fees, but
22 requires issuance of distinguishing plates identifying such
23 vehicles as official vehicles. The state department of
24 transportation or the director of the department of
25 administrative services may order the issuance of regular
26 registration plates for vehicles operated by certain
27 individuals whose business cannot reasonably be conducted in a
28 vehicle marked "official". Those government vehicles bearing
29 regular registration plates are also exempt from the labeling
30 requirements of Code section 721.8 applicable to publicly
31 owned vehicles.

AN ACT

RELATING TO IDENTIFICATION OF PUBLICLY OWNED MOTOR VEHICLES
USED BY PERSONS WHO PROVIDE OFF-SITE OR IN-HOME MEDICAL OR
MENTAL HEALTH SERVICES.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 321.19, subsection 1, unnumbered
paragraph 2, Code Supplement 2005, is amended to read as
follows:

The department shall furnish, on application, free of
charge, distinguishing plates for vehicles thus exempted,
which plates except plates on state patrol vehicles shall bear
the word "official" and the department shall keep a separate
record. Registration plates issued for state patrol vehicles,
except unmarked patrol vehicles, shall bear two red stars on a
yellow background, one before and one following the

registration number on the plate, which registration number
shall be the officer's badge number. Registration plates
issued for county sheriff's patrol vehicles shall display one
seven-pointed gold star followed by the letter "S" and the
call number of the vehicle. However, the director of the
department of administrative services or the director of
transportation may order the issuance of regular registration
plates for any exempted vehicle used by peace officers in the
enforcement of the law, persons enforcing chapter 124 and
other laws relating to controlled substances, persons in the
department of justice, the alcoholic beverages division of the
department of commerce, disease investigators of the Iowa
department of public health, the department of inspections and
appeals, and the department of revenue, who are regularly

exempted vehicle, may issue for in-transit purposes a
pasteboard card bearing the words "Vehicle in Transit", the
name of the official body from which the vehicle was
purchased, together with the date of the purchase plainly
marked in at least one-inch letters, and other information
required by the department. The in-transit card is valid for
use only within forty-eight hours after the purchase date as

indicated on the bill of sale which shall be carried by the driver.
