#### EXPLANATION

22 This bill deletes a provision that appropriations to the  
23 office of grants enterprise management of the department of  
24 management from indirect cost reimbursements to state agencies  
25 shall only be taken from the increase in indirect cost  
26 reimbursements over the amount of indirect cost reimbursements  
27 received during the fiscal year beginning July 1, 2002.  
28 Instead, the bill provides that the appropriations will be  
29 taken from indirect cost reimbursements without qualification  
30 relating to increases over the 2002 level. The bill also  
31 provides that the current annual appropriation of up to  
32 \$125,000 shall be allocated for office expenses, and that an  
33 additional appropriation for FY 2006-2007 and FY 2007-2008 of  
34 \$35,000 each year shall be made to provide grant  
35 identification and writing assistance to state agencies. The
